President's Message

Dear Friends,

Thanks to the generosity of over 13,000 donors to the United Way Thomas Fire and Flood Fund, we are helping our community members who have been directly affected by the disaster.

Starting this month, disaster victims are able to apply for the next phase of relief funding. Between now and April 30, we will distribute as much as \$1.5 million for individual hardship assistance. Prior to the New Year, United Way provided immediate assistance in the form of \$500 prepaid credit cards to approximately 1,000 Ventura County residents whose homes were destroyed by the Thomas Fire.

From now through March 15, application forms for victims will be available at <u>vcunitedway.org</u> and <u>211ventura.org</u>. Applicants can also call 2-1-1 or text "ThomasFire" to 898-211 to find out more. Local agencies will assess the need and eligibility of each applicant. Eligibility will be based on family size and income limit of 120% or less of Area Median Income. Funds will support Ventura County residents' expenses related to housing, livelihood/income, and habitability of their homes.

Since the fund expanded to include flood relief and joint fundraising efforts with our partners at United Way of Santa Barbara, an additional \$500,000 has been donated for fire and flood assistance along the Central Coast.

The outpouring of support has been incredible, and we're so proud to be able to distribute these



DR. BRENDA COMBS INSPIRATIONAL EDUCATOR & SURVIVOR

A little over a decade ago, speaker Dr. Brenda Combs was a homeless crack addict and criminal who had been shot, beaten and raped. Today, having completely turned her life around, the media has landed her journey as being "from homeless to hero." A single mother who successfully obtained a doctorate in organizational leadership, Dr. Combs motivates others with her inspirational story of perseverance.

Once Brenda Combs set her sights on becoming a teacher, there was no stopping her. As a single mother of a young son who suffered a stroke at birth, she juggled three jobs while earning a bachelor's degree in human services. She then went on to get her master's degree and finished with a doctorate in organizational leadership with an emphasis on education. She travels around the world educating single mothers along with others on the importance of education and the power of within.

"If I can do it, anybody can do it," she says. "I think every person has inside of them what it takes to succeed."

Dr. Brenda Combs has received tremendous national coverage, including an article in Readers' Digest and interviews on The Today Show and CNN News.

A special thanks to Stonehouse for hosting the event and for graciously donating the wine and food.






VOLUNTEERS NEEDED FOR COUNT OF HOMELESS PERSONS

BUILDING HEALTHY SMILES

On January 28 and 29, Building Healthy Smiles held an oral health assessment event

at Tierra Vista Elementary School in Oxnard. Working in partnership with the Ocean View School District and Clinicas del Camino Real, we provided oral health assessments and fluoride varnish to 147 kindergarten through 2nd grade students. Children who saw the dentist received an oral health kit with a toothbrush, toothpaste, and floss. Clinicas staff will follow up with the parents of children whose teeth were found to have some decay to encourage them to get treatment. All 324 kindergarten through 2nd grade students at the school also participated in the oral health presentation conducted by Clinicas Health Education staff.

Building Healthy Smiles' next oral health assessment event is on Friday, March 2, from 9 AM to 1 PM at the Simi Valley First 5 Family Resource Center.
